NOTICE IS HEREBY GIVEN that the City of Patterson Planning Commission will hold a public hearing on **Thursday, October 27, 2022, at 7:00 p.m.**, in accordance with AB 361 (Gov. Code, § 54950 et seq.), and the Federal Americans with Disabilities Act, to consider the following:

Public Hearing: Mini-Storage, Architectural & Site Plan Review #22-06, Conditional Use Permit #22-07, APN # 048-043-012

Consideration of a new self-storage facility, located at 201 Poppy Avenue, APN 048-043-012, a 4.73-acre lot. The facility would include approximately 77,000 square feet of building space, mostly for storage buildings along with an office/caretaker residence building. The project would include one- and two- story buildings with storage units of varying sizes, including some temperature-controlled units, and security gates and cameras. The use requires a conditional use permit in the General Commercial zone, where the site is located. The project is categorically exempt from CEQA (§15332 Infill Development).
