### 4. Items from the Public

<u>Dominic Speno, Villa De Lago Developer</u> – addressed the City Council of his 27 years presence before City Council and 7<sup>th</sup> City Mayor Molina. Mr. Speno addressed his Villa De Lago project. Mr. Speno addressed James Burke and John Azevedo and their support. Mr. Speno addressed the City's 2<sup>nd</sup> Quarter of the City's Transportation Occupancy Tax (TOT) being \$38,958.20 Issuing check to the City of Patterson. Mr. Speno stated he would be providing the City (Finance Director Moreno) tonight with a \$90,000 final settlement of the uncollected TOT taxes for the year 2007 due to a criminal act committed against Mr. Speno. Mr. Speno stated that \$86,157.58 was the actual number of tax principal due to the City, but Mr. Speno rounded it up to \$90,000. Mr. Speno asked for City Council to consider on a future Council Agenda, not certain if legally correct on the process - his request for the City to waive exorbitant penalties and interest. Mr. Speno requested to have item on the agenda or the correct process to address his request.

Deputy City Attorney White addressed Mr. Speno request, stating taking anything less than what is owed per the court order would require Council action, therefore item would have to be agenized. Deputy City Attorney White suggested that City Finance Director Moreno accept the check on behalf of the City, but not cash it until staff gets Council direction on the request.

Item to be addressed by City Staff and Counsel – item to be placed on a future City

Council Agenda per Deputy City Attorney White.

<u>Craig Saalwaechter, Pittscottie Lane, Patterson</u> – addressed the City Council on his issues regarding Animal Control Services. Mr. Saalwaechter stated his support for Patterson Fire and Stanislaus County Sheriff's Department (Patterson Police Services). Sheriff's Department response time being fantastic.

<u>Joyce Buehner, Patterson</u> – addressed the City Council stating her support for the City helping the Board feel safe and have security. Seniors at the Senior Center would like to have the same safeness and security of incoming/outgoing persons and making sure everyone is accounted for. Request for the City Council to take action to protect Seniors at the Senior Center in case of an emergency, that it is secure so that everyone that enters is identified and accounted for. Mr. Buehner suggested for item to be placed on a future City Council agenda.

Mayor Molina requested for the City Manager to work with the Department Head(s) and addressed item of a safety plan or measure for the Hammon Senior Center including other City facilities.
