NOTICE IS HEREBY GIVEN that the City of Patterson Planning Commission will hold a Regular Meeting on **Thursday, August 26, 2021, at 7:00 p.m., via Video Conferencing and Zoom Teleconference**, to consider the following:

Public Hearing: Caligrows-Holdings, LLC - Architectural & Site Plan Review #21-04, Conditional Use Permit #21-05, Development Agreement #21-01, APN # 021-085-013

Review of an Architectural and Site Plan Review and Conditional Use Permit for the construction of three buildings located north of Keystone Pacific Parkway, approximately 1700 feet east of the intersection with Rogers Road, also known as APN 021-085-013, a 14.47-acre lot. All three buildings would measure approximately 170,892 square feet, for a total building area of 512,676 square feet. Each of the three buildings would be used for cannabis cultivation, storage, and distribution. The site plan includes parking, landscaping, and other appurtenances, as well as a new road that would extend along the eastern edge of the lot. The Planning Commission will also be making a recommendation to the City Council regarding a Development Agreement associated with this project. The use is consistent with the West Patterson Light Industrial Zone, where the lot is located, subject to approval of a conditional use permit and development agreement.
