1. Call to Order

The regular meeting of the Public Safety Committee was called to order via teleconference at 5:16 p.m. by Vice Chair Ginyard.

4. Motion to Approve Meeting Minutes of June 22, 2021

Member Flynn moved to approve the meeting minutes of June 22, 2021. The motion was seconded by Committee Member Rishebarger and approved by a 4-0 vote.

5. Sheriff Department Budget Understanding

City Manager Irwin went over the Sheriff Department budget presentation.

Member Flynn asked if the numbers on slide one is estimated or projected. City Manager Irwin explained it was estimated for this fiscal year 2021-22. Member Flynn also asked historically, has the police run with a profit or deficit. City Manager Irwin explained the contract with Stanislaus County and how there is never a profit or deficit.

Vice Chair Ginyard asked if the Police Department has ever hired anyone at the age of 18. Police Chief Clayton stated they do not allow anyone under the age of 21 to
