**Public Hearing: Tentative Parcel Map #22-03 - Keystone Pacific Business Park LLC
APN 021-085-013**

A public hearing to consider a tentative parcel map to divide an existing parcel, APN 021-085-013, located on the north side of Keystone Pacific Parkway, approximately 1, 200 feet northwest of the intersection with Park Center Dr. The site is currently 14.47 acres. Approval divides the site into two parcels, measuring approximately 6.00 acres and 7.45 acres, and a future parkway located along the site’s eastern boundary.
